Notice Regarding Approval of New Listing for Toranvia Co., Ltd.

Toho System Science Co., Ltd. and R&D Computer Co., Ltd. (collectively referred to as the “**Companies**”) plan to establish a wholly owning parent company of the Companies, Toranvia Co., Ltd. (the “**Joint Holding Company**”), through a joint share transfer scheduled to take effect on April 1, 2026, with the Companies becoming wholly owned subsidiaries. Today, the new listing of the Joint Holding Company on the Tokyo Stock Exchange (“**TSE**”) Prime Market was approved as follows.
